Article 1: Organization of the Competition

The company: **IZIPIZI**, registered in the Trade and Companies Register under number 52447813800091 and whose registered office is at 19, rue de Calais 75009 Paris (hereinafter the Organiser), organizes from **02/12/2022 to 08/ 12/2022** included, a free competition with obligation to purchase entitled “ **CHRISTMAS GAME** ” (hereinafter the “Game”).

Article 2: Object of the game

From December 2 to 8, try to win a Christmas Box!

Participation in the Game implies unreserved acceptance of these rules in their entirety, hereinafter “the Rules”.

Article 3: Date and duration

The Game takes place from 02/12/2022 to 08/12/2022 inclusive.

The Organizer reserves the right to postpone, modify, cancel or renew this Game if the circumstances so require. In any event, its liability cannot be engaged in this respect.

Article 4: Conditions of participation & validity of participation

4-1 Conditions of participation

The Game is open to any adult (and minor) natural person who has made an online purchase on the Izipizi website or in a store (see article 2-1), who has a personal email address on the start date of the Game (email) to which it may, if necessary, be contacted for the purposes of managing the Game (hereinafter the **"Participant"**).

Are excluded from any participation in the Game the people who participated directly or indirectly in the development of the Game as well as the members of their family (same name, same postal address), the employees of the organizer and the subcontractors of the 'organizer.

Only entries that comply with all the stipulations of this article will be accepted.

The organizer therefore reserves the right to carry out any checks it deems useful with regard to the identity and address of each Participant. In this respect, any indication given in the participation form, which would be incomplete, erroneous, falsified or which would not make it possible to identify a Participant or his contact details will result in the cancellation of the participation in question.

4-2 Validity of entry

Participation in the Game takes place exclusively via the Internet or when making a purchase in one of the participating shops, to the exclusion of any other means, including by post.

To participate in the Game, each participant must, from December 02 to December 08, make a purchase on the IZIPIZI online store or in store (see article 4-2), one "Christmas Box" is up for grabs per day.

2 ways to participate:

- Customers placing their order on the website, for any order, must fill in their email address when placing the order (screenshot at the end of the rules, article 16).
- Customers placing their order in participating shops must check a box on the cash register software called "Advertising by email" (screenshot at the end of the payment, article 17). In the new cash register software, this will be "Commercial authorisation".

The organizer reserves the right to eliminate from the Game any entry that does not comply with the rules.

The same sanction will apply in the event of multiple fraudulent entries, ie beyond the limits defined in these rules. The Organizing Company has the option of unilaterally terminating the Participant's participation, without notice or justification, and without this being able to found any claim against it on the part of the Participant, in particular if the information provided is contrary to good morals and /or constituting a disparagement of the Organizing Company or its products and/or likely to offend consumers.

Article 5: Designation of winners

The draw for the winning ballot will be made by Anna PESTEL (a.pestel@izipizi.com) on Friday December 09, 2022.

This date may be postponed if one of the persons in charge of the operation designated above cannot be available that day and a new date would then be set for the draw.

Any participation containing a false declaration or an erroneous and/or incomplete declaration and/or not respecting the present rules, will be considered as null and will involve the designation of another participant

by a new drawing of lots.

Article 6: Prizes/Prizes

6.1 – Commercial value of prizes:

The prizes are offered by the Organizer and in this sense constitute “prizes”.

To be won by drawing lots:

A Christmas Box worth €55. There will be one batch per day, so 7 batches in total.

The organizer reserves the right to change the prize without notice. If this were the case, the value of the lot will be equivalent to or greater than the replaced product.

This prize may not be taken back, exchanged or subject to the payment of its counter-value in cash or by cheque. Any contestation of the prize for any reason whatsoever will be tantamount to a definitive refusal of the latter.

Article 7: Delivery or withdrawal of Lots

After verification of the regularity of participation and the conditions for awarding the prize in question, the winners will receive their prize by e-mail.

The winners will be contacted by email by a.pestel@izipizi.com at the end of the game.

After a period of 7 days, without response to the email inviting the winner to present himself, the prize will be lost. It may be awarded to another participant drawn at random or will remain the property of the organizing company.

Incorrect e-mail address, incorrect mailing address: (information by e-mail) If the e-mail address is incorrect or does not correspond to that of the winner, or if for any other reason related to technical problems that do not allow the e-mail to be correctly routed information, the organizer can in no way be held responsible. Similarly, it is not up to the organizer to search for contact details of winners who cannot be contacted because of an invalid or illegible email address, or an incorrect postal address.

Prizes not withdrawn:

Winners who cannot be reached, or who do not respond within 7 days to provide their address, will not be entitled to any prize, compensation or indemnity of any kind whatsoever.

The prizes awarded are personal and non-transferable. In addition, the prizes cannot under any circumstances be the subject of any dispute on the part of the winners, nor of an exchange or any other consideration of any kind whatsoever.

Article 8: Collection of information – Data Protection Act

The personal data collected as part of the participation in the game are recorded and used by the organizer for the necessities of their participation and the allocation of their earnings.

Participants may request not to appear or be removed from the file at any time, they will have a right of access, rectification and deletion of data concerning them on simple request to the address of the game in

accordance with the Data Protection Act and Freedom of January 6, 1978, amended by Law No. 2004-801 of August 6, 2004 relating to the General Data Protection Regulations (RGPD) on the protection of individuals with regard to the processing of personal data and of decree n°2005-1309 of October 20, 2005.

Persons who exercise the right to delete data concerning them before the end of the game will be deemed to have waived their participation.

Any request must be sent by post to the address of the organizer mentioned in article 1.

The personal data collected by the organizing company (surname, first name, postal address and participants' email) when participating in the competition are only collected and processed within the purpose of ensuring the organization and smooth running of the competition and in particular the awarding of prizes. They will only be stored and kept to ensure the smooth running of the game and for a maximum period of 6 months from the closing of the operation. Your personal data will be destroyed at the end of this period.

For the organization of the Game and for the sole purpose of contacting the Winner, the Organizing Company will have access to the personal details of the Participants, the Winner and the Beneficiary. In accordance with its privacy policy www.izipizi.com/fr/content/14-politique-confidentialite-donnees-personnelles, the organizing company may communicate the personal data of each participant to the judicial authorities in order to respond to an injunction or other request for such authorities.

Article 9: Liability

The Participant acknowledges and accepts that the sole obligation of the organizer under the Game is to submit the collected entries to the draw, provided that his entry complies with the terms and conditions of the Rules, and to award the prizes to the winners, according to the criteria and procedures defined in these Regulations.

The organizer cannot be held responsible, without this list being exhaustive, for any dysfunction of the "Internet" network preventing the smooth running of the game, in particular due to external malicious acts. The organizing company cannot be held responsible in the event that one or more participants are unable to connect to the game site due to any technical defect or any problem linked in particular to network congestion. The organizing company makes every effort to provide users with available and verified information and/or tools, but cannot be held responsible for errors (in particular display on the game sites, sending of erroneous e-mails participants), lack of availability of information and/or the presence of viruses on their site, any malfunction of the Internet network preventing the smooth running of the game; interruptions, data transmission delays, failures of the player's computer, telephone, modem, telephone line, servers, Internet access providers, telephone operators, computer equipment, software; the loss of any e-mail and more generally, the loss of any data, the consequences of any virus, computer bug, anomaly, technical failure, any damage caused to a participant's computer, any technical failure, hardware and software of any kind, having prevented or limited the possibility of participating in the game or having damaged a player's system. It is up to all participants to take all appropriate measures to protect their own data and/or

software stored on its computer and telephone equipment against any infringement. The connection of any person to the site and their participation in the game is under their sole responsibility.

The organizing company may cancel or suspend all or part of the game if it appears that fraud has occurred in any form whatsoever, in particular in a computerized manner within the framework of participation in the game. It reserves the right, in this case, to right not to allocate the prizes to fraudsters and/or to prosecute the perpetrators of these frauds before the competent courts.

In all cases, if the proper administrative and/or technical progress of the game is disrupted by a virus, computer bug, unauthorized human intervention or any other cause beyond the control of the organizing

company, the latter reserves the right to interrupt the game.

Likewise, participation in this game implies knowledge and acceptance of the characteristics and limits of the Internet both in terms of technical performance, response times for consulting, and for querying or transferring information, the lack of protection of certain data against possible misappropriation or hacking and the risk of contamination by possible viruses circulating on the network.

Article 10: Force majeure / reservations

The responsibility of the organizer can not be incurred if, for a case of force majeure or beyond its control, the game had to be modified, shortened or canceled.

The organizer reserves the right to carry out any verification that it deems useful, relating to compliance with the rules, in particular to exclude any participant who has made an inaccurate or misleading or fraudulent declaration.

Article 11: Nullity – Resolution of disputes

If one or more provisions of these rules were declared null or inapplicable, the other clauses would retain all their force and scope and could not in any way affect the validity of the Rules themselves.

The Rules are governed by French law without prejudice to any rules of conflict of laws that may exist. Participants are therefore subject to French regulations applicable to games. Any difficulty in applying or interpreting the Rules will be resolved exclusively by the organizer.

No telephone request or complaint concerning the application or interpretation of these rules will be answered. Any dispute or complaint relating to the Game and/or the draw must be made by registered letter with AR to the address of the organizer. And no later than ninety (90) days after the deadline for participation in the Game as indicated in these rules. In the event of persistent disagreement on the application or interpretation of these rules, and in the absence of an amicable agreement, any dispute will be submitted to the court having the right, to which exclusive jurisdiction is attributed.

In order to safeguard the same chances for all participants in this Game, the Organizing Company reserves the right not to award the prize to fraudsters and, or to prosecute before the competent courts the perpetrators of these frauds: in particular Article 323-2 of the Penal Code (amended by Law No. 2004-275 of June 21, Art 45 II Official Journal of June 22, 2004): "the act of hindering or distorting the operation of an automated data processing system is punishable by 5 years imprisonment and a fine of €75,000.00".

Article 12: Filing and consultation of the Rules

The rules can be consulted free of charge throughout the duration of the game at the following address: <http://www.depotjeux.com/>. Participation in the game implies pure and simple acceptance of these rules in all their provisions, as well as the laws and regulations applicable to competitions in force in France.

The rules may be modified at any time in the form of an amendment by the organizers, in compliance with the stated conditions, and published by online announcement on the site. The amendment is filed via [depotjeux](http://www.depotjeux.com/) with the study of Maitre Doniol located 8 Rue Souilly - 77410 Claye Souilly, bailiff, depositaries of the regulations before their publication.

It will come into effect from the time it is posted online and any Participant will be deemed to have accepted it by the simple fact of their participation in the Game, from the date of entry into force of the modification. Any Participant refusing the modification(s) made must stop participating in the Game.

Article 13: Reimbursement of participation fees

Reimbursement of the connection costs necessary for effective participation in the game (flat-rate basis of 2 minutes of connection, i.e. €0.39 including tax) can be obtained upon written request and must be sent within 10 days of participation, specifying the date. connection, subject to verification by the organizing company of the actual participation of the applicant.

The stamp required for the reimbursement request will also be reimbursed on written request (current slow rate, base 20g).

The refund will be made in the form of a bank transfer. The request must be made in writing and be addressed to the organizing company (c/f in article 1)

Reimbursement will be made on condition that the participants clearly indicate:

- their surname, first name, full address,
- the surname of the Game concerned,
- a photocopy of proof of identity (identity card or passport),
- a photocopy of the last detailed telephone and/or service provider bill (this photocopy will serve as proof of address, indicating the date and time of participation and the amount of the communication,
- a RIB from a French banking institution

No request for reimbursement of the connection can be honored if the conditions indicated above are not met, and no request can be made by telephone.

Requests for reimbursement will be honored within 4 weeks of receipt of the written request.

Please note: only one request for reimbursement per household (same name, same my address) will be accepted.

Access to the site on a free or flat-rate basis (such as in particular a connection by cable, ADSL or specialized link) cannot give rise to any reimbursement insofar as the subscription to the services of the access provider is contracted. on behalf of the Internet user and/or for his use of the Internet in general and that the fact that the participant connects to the site and participates in the game does not incur any additional costs or expenses.

Article 14: Industrial and intellectual property

The reproduction, representation or use of all or part of the elements making up the game offered therein is strictly prohibited. All brands or product names mentioned are registered trademarks or product names of their respective owners.

Article 15: Parental authorization for minors

Any Participant under the age of 18 must obtain the prior authorization of a parent or guardian to participate in the Game and accept these rules

Candidates under the age of 18 on the date of the launch of the game and who participate in the competition as a candidate (s) free (s) will have to obtain the prior agreement of the parents. An e-mail sent automatically to the e-mail address of the parents which will be indicated by the participant will be worth acceptance on their

part. In the absence of the parents' e-mail address, the candidate may have a letter of parental consent signed, scanned and returned to us electronically. In the absence of parental authorization on the closing date of the game, the participant will be automatically unregistered. The parental agreement will explicitly stipulate the acceptance of the minor's participation, and the acceptance that the participant receives, if applicable, one of the competition prizes. "Parents" means the person(s) with parental authority over the participating minor (father and/or mother, or legal representative). The organizers reserve the right to carry out all verifications, in particular of identity and/or parental authority, before any acceptance of participation or awarding of prizes.

The Organizer may ask any minor participant to provide proof of this authorization and, if necessary, disqualify a Participant who cannot provide proof of this authorization. Any participating minor who is not able to provide this justification within 30 days will be excluded from the Game and any winnings will automatically become the property of the organizing company, and no complaints will be accepted
